Committees:

- Are composed of Board members, staff, volunteers or interested community members as
 deemed appropriate by: <u>CCWN's By-laws</u>, Board Policies, and <u>approved Committee Terms of Reference</u>.
- The Board President serves "Ex officio" on all Board Standing and Temporary Committees. By virtue of the office held as President, the President's attendance does not affect quorum, and they are entitled to vote.
- Share the workload.
- Identify and utilize the expertise of Board members to propose ideas and solutions.
- Develop a process where the committee does the detailed work, and the Board accepts or gives recommendations.
- Create a Work Plan at the beginning of the year, and review its performance at the end.
- Facilitate learning, input and where appropriate, share information and/or collaborate to support the work of <u>CCWN</u>,
